**Subject: Guidelines for opening places of worship under Green Zone during Restricted Movement Control Order (PKPB)**

1. The Cabinet Minister Y.B. Dato' Sri Ismail Sabri Bin Yaakob announced yesterday 21/05/2020 the guidelines for the opening of places of worship. He also announced the granting of approval to 174 places of worship including 8 Gurdwaras to open with effect from 10<sup>th</sup> June 2020. The opening is conditional on these places of worship strictly complying with the Standard Operating Procedure (SOP) imposed for the opening.
2. Kindly find attached:
  - (a) "Garis Panduan Pembukaan Rumah Ibadat dalam Zon Hijau Semasa Tempoh PKPB" – Please see Appendix-A

This is issued by the Kementerian Perpaduan Negara for guidance by Committees of the Places of Worship (in our case Gurdwaras) and the Sanggar. This has to be followed by the Committees of the 8 Gurdwaras allowed to open and any further Gurdwaras allowed to open later. These guidelines will be applicable until the MCO is in force.

- (b) Garis Panduan as in Appendix-B.

This is prepared based on the SOP approved.

It is similar to Appendix-A but it gives SOP in greater detail.

The following points from the SOP are highlighted:

- (i) At one time there can only be maximum of 30 persons allowed to enter and strict Social Distancing to be observed.
- (ii) Signboards relating to Social Distancing of at least 1 Meter should be put up.
- (iii) Sanggar members who are above 70 years old and below 12 years old are not allowed to be present. This is for their own safety. This does not apply to Granthi Sahib and Gurdwara staff.
- (iv) Must set-up a centre and provide a book for Sanggar members to record their Name and Contact Number. No record of a person's temperature is required.
- (v) All present at Gurdwara Sahib must wear Masks for the duration they are there.
- (vi) The Gurdwara committee members and the Sanggar attending must carry with them their identity cards.
- (vii) The gates of the Gurdwara can only be opened for the period allowed for Prayer and to be closed immediately after Sanggar members have left.
- (viii) No Langgar is allowed. However, "Packed Food" can be given out but cannot be eaten at the Gurdwara Sahib.
- (ix) Strict cleanliness and Social Distancing to be observed at all times while at Gurdwara premises.

3. The 8 Gurdwaras given approval to open with effect from 10/06/2020 are:

- i) G.S. Sandakan
- ii) G.S. Greentown. Ipoh
- iii) G.S. Tapah
- iv) G.S. Kangar
- v) G.S. Tambun

- vi) Wadda G.S. Ipoh
- vii) G.S. Muar
- viii) G.S. Bercham
- This Gurdwaras are only allowed to open on Sundays from 7.00 AM – 2.00 PM. At all other times, the Gurdwara gates are to remain closed.
- The Gurdwara approval formats have not yet been received from the Ministry of Unity. We have confirmed the status of approval with the Ministry. The approval formats once received will be forwarded to the above 8 Gurdwaras named.
- There were 26 applications from Gurdwaras. The balance 18 Gurdwaras whose applications were not approved were from the Red or Yellow Zones.

#### 4. New Applications

- Some Gurdwaras had called to ask whether they could apply for future opening of Gurdwaras.
- Any Gurdwara who wishes to apply to open the Gurdwara in the future may do so by filling and submitting the attached form titled “Cadangan Rumah Terpilih Dan Berdaftar Dalam Zon Hijau Semasa Tempoh Perintah Kawalan Pergerakan Bersyarat (PKPB)” marked as Appendix-C.
- The Gurdwara who wishes to apply must be in the Green Zone. The Applications can be submitted to the MGC office from 08/06/2020 onwards.


#### 5. General

The remaining 113 Gurdwaras may continue to follow the earlier SOP. For ease of reference, some of the guidelines are:

- (i) Gurdwara gates to remain closed and no functions or Langgar allowed in Gurdwaras.
- (ii) Where someone has passed away then the Sadharan Paath can be commenced in the Gurdwara Sahib and the Antham Ardas Bhog done. Here family members must report to the police and fill up the MCO form. The police will give direction and can allow up to 10 persons.

For the purpose of cremation rites, there can be up to 20 family members gathered in the family house.

- (iii) Vide Ketua Pengarah, Jabatan Pendaftaran Negara letter dated 12/05/2020 all Marriage Ceremonies are postponed until 31<sup>st</sup> July 2020.
- (iv) Some Gurdwaras have been carrying out welfare work in the past, which may be continued but the Gurdwaras gates to remain closed.

Jawatankuasa:

- Pembersihan premis & saringan kesihatan
- Sedia kaunter saringan kesihatan & buku rekod kesihatan
- Pakai penutup hidung & mulut

Penganut:

- Dilarang berkumpul di luar rumah ibadat

### SEMASA DI DALAM RUMAH IBADAT

Jawatankuasa, ketua agama, petugas & penganut:

- Penganut sentiasa berada di tempat yang telah ditandakan
- Dilarang berkumpul di dalam kawasan rumah ibadat
- Wajib pakai penutup hidung & mulut

### SELEPAS ACARA IBADAT

Jawatankuasa:

- Terus menutup rumah ibadat, pastikan tiada penganut berada di dalam kawasan dan kunci premis

Penganut:

- Terus bersurai secara teratur, elak bersentuhan
- Dilarang berkumpul di dalam kawasan rumah ibadat

## APPENDIX-B

### **GARIS PANDUAN PEMBUKAAN RUMAH IBADAT DALAM ZON HIJAU SEMASA TEMPOH PERINTAH KAWALAN PERGERAKAN BERSYARAT (PKPB)**

The following Rules are to be observed when opening Gurdwara Sahib in Green Zone during Perintah Kawalan Pergerakan Bersyarat (Conditional Movement Control Order - CMCO). These Rules have been prepared as guidance for all Gurdwaras given approval to operate during Conditional MCO.

Rules to be enforced by Gurdwara Committees:

1. Kehadiran penganut agama tidak melebihi 30 orang pada satu masa serta mematuhi jarak sosial (Social Distancing) serta dalam keadaan bersih.
2. Penanda Jarak (1 meter) wajib diletakan dilantai, tidak mudah tanggal dan mudah dilihat
3. Panganut agama yang berumur 70 tahun ke atas dan kanak-kanak dibawah umur 12 tahun tidak dibenarkan hadir. Ini *tidak* termasuk Granthi/Pemuzik dan pekerja.
4. Penganut yang mempunyai gejala seperti demam, batuk, sesak nafas, sakit tekak dan selsema tidak dibenarkan hadir.
5. Kaunter saringan kesihatan hendaklah diwujudkan di-depan Gurdwara. Buku Rekod kehadiran hendaklah disediakan untuk merekod Nama dan Nombor Talipon panganut yang hadir.
6. Para panganut agam hendaklah membersihkan tangan, sama ada dengan air/sabun atau hand sanitizer.

## APPENDIX-B

7. Jawatankuasa pengurusan Rumah Ibadat dan penganut agama diwajibkan memakai penutup hidung dan mulut (Face Mask).
8. Melakukan pembersihan ruang dan Kawasan sekitarnya termasuk tandas dan semua ruang sebelum dan selepas acara keagamaan.
9. Jawatankuasa pengurusan Rumah Ibadat dan penganut agama hendaklah membawa Kad Pengenalan diri.
10. Pintu Rumah Ibadat hanya dibuka untuk penganut mengikut waktu operasi.
11. Tidak dibenarkan upacara atau aktiviti yang melibatkan sentuhan.
12. Sebarang penyediaan atau pemberian makanan adalah secara "packed food" dan tidak dibenarkan di-Rumah Ibadat.
13. Penganut agama hendaklah terus bersurai selepas selesai melaksanakan upacara keagamaan.
14. Rumah Ibadat di-tutup dengan kadar segera selepas selesai upacara keagamaan.
15. Tidak bersentuhan sepanjang masa berada dikawasan Rumah Ibadat.
