Re : RESOLUTIONS Approved by the AGM of MGC on 3rd Dec 2016

The following 3 Resolutions were approved after discussion by the Malaysian Gurdwaras Council AGM held on 3-12-2016 at Sikh Centre , Kuala Lumpur.

1. 1st Resolution:

“WHEREAS at a Meeting of the Representatives from MGC , KDM. SNSM, Melaka Vidyala on 21-05-2016 and attended by Sikh Scholars a resolution titled ‘Unity of Gurdwaras and Sangat’ was approved which is filed here as Appendix-1.

The said Resolution (Appendix-1) was then considered by the MGC at its EXCO meeting held on 28-05-2016 and was unanimously approved.

The Annual General Meeting 2016 of the Malaysian Gurdwaras Council after considering the said Resolution (filed as Appendix-1) unanimously approves it and instructs Gurdwaras in Malaysia to follow and abide by it”.

2. 2nd Resolution:

The AGM after deliberating on the issue of SIKH REHET MARYADA, passed the Following Resolution:

- i) All Gurdwaras in Malaysia must follow and abide by the Panth Parvanat SIKH REHET MARYADA (1945) and the teaching of Sri Guru Granth Sahib (SGGS) Ji.
- ii) The Malaysian Gurdwaras Council Executive Committee (EXCO) is hereby empowered to take any and all action it deems necessary to ensure compliance with the Sikh Rehet Maryada.
- iii) The MGC EXCO is hereby empowered to issue directives to Gurdwaras and individuals barring Societies, Organisations, Granthis, Preachers, individuals from preaching or doing Kirtan Katha, or giving gurbani Santhia in a Gurdwara which Preaching , Katha/ Kirtan, Gurbani Santhia appears to the EXCO to be in contravention of the SRM and the Gurdwaras shall comply with such directive of the MGC EXCO accordingly.


3. 3rd Resolution :

The AGM considered the 3rd Resolution proposing the creation of a Malaysian Gurdwaras Council Istri Satsang Trust and the constitution for it and unanimously approved the proposed Constitution (Exhibited as Appendix-2 to the resolution) and the creation of a trust.

The Gurdwara Parbandhak Committees are kindly requested to note the above 3 Resolutions passed at the MGC AGM held on 3-12-2016
