**Subject: Gurdwaras entitled to claim 10% discount on monthly
Electricity Tariff Bills**

The TENAGA NASIONAL has been giving 10% discount on monthly Electricity Tariff Bills to Industrial Consumers, Commercial Consumers, Domestic Consumers, etc. for the last many decades. This Tariff rates were revised upwards in 2011 but the 10% discount was maintained for the above-mentioned consumers including Places of Worship such as Gurdwaras.

The Tenaga Nasional had made announcement vide letter dated 29/05/2011 relating to this 10% discount entitlement. The relevant part is reproduced below:

“The 10% discount on electricity bill currently enjoyed by Government schools, Government institutions of higher learning, places of worship and welfare homes registered with the Government is maintained. The 10% discount will also be extended to educational institutions partly-funded by the Government.”

Procedure for applying 10% discount:

- i. If the Gurdwara Sahib is registered with ROS or is registered under a Trust Deed, etc, the Gurdwara need to take the document to the nearest KEDAI TENAGA and apply for the 10% Exemption on their Electricity Bills.

- ii. Where the Gurdwara is not registered with the ROS or under a Trust, then it needs to obtain a letter from MGC confirming that their Gurdwara is legally constituted under Article 11 of the Constitution and are entitled to claim the 10% discount.
- iii. If any difficulty arises in obtaining the 10% discount, then kindly notify the MGC Office Manager (Tel No.: 03-4050 2329) and MGC will help coordinate the matter with Tenaga Nasional.

Many Gurdwaras have applied in the past to obtain such discount. Those Gurdwaras not enjoying this 10% discount in Electricity Bills at the moment, are kindly requested to make an application to their nearest Kedai Tenaga.
