Re : Allegations in audio by a woman against few individuals

An Audio surfaced yesterday (20-03-2017) making allegations against few individuals including MGC President. The audio blamed the named individuals as responsible for her predicament and that she was being forced to embrace Islam.

Thus, as the MGC President, it is my duty to explain to the Gurdwaras and Sanggat the actual facts.

The Audio clip is a total lie and is clearly aimed at maligning the individuals named and the MGC, despite the fact that the MGC had gone out of the way to help this lady.

Here are the facts :

1. The voice in the audio clip is that of one Kulwinder Kaur and an Indian National.
2. The said Kulwinder Kaur (KK) came to MGC office in early December, 2016.

As per procedure, Bhenji Amar Kaur had interviewed her and when I came to the office in the evening as usual, I was briefed by her. I interviewed the said KK a bit later in presence of Bhenji Amar Kaur whereby KK informed that her daughter had been kidnapped by Desi boys and they were asking ransom money. That she (KK) had lodged a police report to that effect on 30/11/2016 and was assisted by Giani Daljit Singh, since she (KK) had no passport with her and her visit visa had expired a few days ago. I then told KK to come back the next evening.

3. The next day, I had with me present also my brother plus a police officer and a stout built gentleman, After discussing with KK, we decided to go to premises where KK alleged her daughter was kept aiming to free her and get the “kidnapper” arrested. This was because, if any delay, the person may elope with KK’s daughter. We went to the flats as guided by KK. At the guard-house KK alighted and went to the guard to make enquiries. She came and told us that the Desi boy was no more staying there and had left.
4. KK came back again the next evening and told that the Desi boy was staying with her daughter in Batu Caves. Police were alerted to this information. The next night police took KK to Batu Caves area but there was no sign of the Desi boy and the girl.
5. Two to three days later while KK was in MGC office, she received a phone call from the supposed kidnapper called Ram Singh or Rahul. I then spoke to this Ram Singh and told him of the consequences and what he was doing was wrong. He told me that the girl wants to marry him and she does not want to go back to her mother. I told him whatever it was, he must return the girl to the mother. He promised to return the girl next day to the mother KK, who at that time was staying with an agent named Kuldip Singh. The girl was returned to her mother by the Desi boy next day. A day later KK came again to MGC office to inform that the girl again had run away to the boy.
6. Around this time an video emerged, which was sent by the Desi boy to the police. The video was sent by police to MGC. The video showed KK and agent Kuldip Singh having meeting with 3 Desi boys and her daughter sitting with one of the Desi boys with her arm in his arm laughing away happily. The video also showed KK talking aggressively and demanding that the Desi boy pay her “7 lakh” and then he could take her away. She said she wanted the money as compensation for money spent on her education.
7. In the evening the Police Officer, Bhenji Amar and I myself confronted her with the video. That this was no kidnapping and there was no ransom demand. But instead it was she demanding “7 lakh” before the Desi boy could take her daughter away. I then told KK to get Ram Singh on the line for me to speak. He confirmed the video and alleged that the mother wanted to push daughter into vice and that he was helping the girl.
8. After the exposure of this video, the Police and the others who were helping out said that KK had said so many lies over the last month that they do not wish to assist further in the matter.
9. I still told Bhenji Amar Kaur to assist KK in any way possible, I advised KK to go back to India as she was vulnerable and that her social visit pass had expired a few months ago. That Bhenji Amar Kaur will take her to Indian High Commission and assist in getting exit pass. That we will bear cost of her going back. KK refused this offer, saying that MGC should get the Desi boy arrested and break his legs.
10. Few days later KK informed Bhenji Amar Kaur that she had lodged another police report against the agent Kuldip Singh and that she was no more staying with him but was now staying in Bandar Baru Sentul Flats. This was somewhere end of December, 2016. KK said she was assisted by a Sikh “B” to lodge the report. MGC was given a copy of the report.
11. KK always complained and sometimes used foul language. She wanted MGC to arrest the Desi boy. I told her, police say, it is not a kidnapping case but more like a family dispute between mother, daughter and the Desi boys.

Once the video surfaced showing KK making demand of “7 Lakh”, other Desi boys met me and told me to be careful of KK.

12. The MGC last saw her around end of February, 2017, where we told her if she knew of daughter’s where about we will try to talk to the Desi boy. She always repeated that she owes RM15,000 to the agent and that in India their “Paili(farmland) ghanai teh dhari hoi”. That MGC must help so that the Desi boy pays the amount. We told her we could not do this. But if she wanted to go back we will assist and finance her trip.

It was then she said that if MGC and the others do not help, she knows a Pakistani man who can help her to catch the Desi boy and that she would convert to Islam. Bhenji Amar Kaur had then scolded her for being ungrateful for all the help given and now trying to threaten MGC. I just told her that MGC had gone out of the way to help her and despite her repeated lies, we will help her to go back.

After about three weeks, this audio from her emerged.

Conclusion :

From the above it is clear that MGC acted throughout responsibly to assist KK. She had lied about ransom demand. In fact it was she who had demanded payment for giving away her daughter. The Desi boy also alleged that the mother was forcing her daughter into immoral earnings.

There are so many witnesses to this. The earlier video was also seen by many individuals.

Her allegation that for 4 months she has been forced to stay with a Pakistani is false, as until end of February she was staying in Sentul Flats.

It appears, that some divisive group has taken advantage of the situation and picked the most vulnerable part to attack MGC, i.e. threat of conversion to Islam. The video emerged simultaneously yesterday in Ipoh, Selayang and KL from members of this extreme group.

A lot of dirt is being thrown at MGC, but MGC will emerge as a Lotus flower to the top, leaving such divisive elements in the dirt that they are hurling.
